

TERMS AND CONDITIONS GOVERNING THE
“[.Samsung Galaxy S10 Netflix Offer on Idea]”

A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO ALL VODAFONE IDEA LIMITED (HEREINAFTER “**IDEA/VIL**”) PREPAID SUBSCRIBERS (SUBJECT TO ELIGIBILITY) PARTICIPATING IN THE OFFER KNOWN AS “Samsung Galaxy S10 Offer on Idea ” DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER. BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“TERMS AND CONDITIONS”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

FOR THE PURPOSES OF THESE TERMS AND CONDITIONS, WHEREVER THE CONTEXT SO REQUIRES “YOU” OR “YOUR” SHALL MEAN ANY NATURAL PERSON WHO BEING AN ELIGIBLE SUBSCRIBER HAS PARTICIPATED IN THE OFFER.

B. DEFINITIONS

1. Logon to the website www.vodafone.in and click on the homepage banner to see the Offer details.
2. Select the product/handset from Samsung S10 series on Samsung e-store page.
3. Enter the promo code **MYIDEA** and complete the handset purchase transaction.
4. **Offer Benefits:**

A Prepaid Benefits: Unlimited Calls + 2GB Data per day for 365 days free..

5. This Offer can be availed only once on a Idea number.
6. This Offer is applicable only one (1) time for one (1) device. The Offer cannot be availed for more than one (1) time on the same device on which the Offer has already been availed. .
7. The Offer benefit of prepaid will be attached to Eligible Subscribers within 72 Hrs. from the time of delivery of handset.
8. Samsung India Electronics Limited (“Samsung”) assumes complete responsibility for the delivery of the handset and VIL shall not be held responsible for the same.
9. It is unreasonable to use of the Offer benefits where Your use of the Offer benefits is reasonably considered by VIL to be fraudulent use, to be contrary to the way the Offer benefits are intended to be used (“Intended Use”), or to adversely affect the VIL network or other VIL customers' use of or access to the Offer benefits or the VIL network.

 - moves out of his home network of Vodafone;
 - deactivates his Vodafone connection and ports out to another telecom operator

Samsung shall indemnify and keep indemnified VIL, its officers, directors, employees, customers, affiliates and agents or representatives harmless from and against any and all actual claims, suits, proceedings, action, liabilities, expenses, costs (including attorney's fees and court costs), losses or damages of whatsoever nature, which VIL may incur, pay or become responsible arising out of or in connection of the devices purchased by the Eligible Subscriber under this Offer.
